After review and discussion on removing references to "tanks" in the CC&R's, it was recommended that after the Annual Meeting a special meeting be held to obtain a quorum vote on this recommended change.

Landowner Survey

Mr. Shali has continued to work with the Board to develop a landowner's survey. This will soon be distributed in an effort to gather feedback from owners on topics ranging from demographics to projects/services that the landowners would support in the future.

NEW BUSINESS:

Public vs Private Roads in Timberlake Ranch

Ms. Pedersen identified that while Timberlake Road is a public road, all side roads in the Community are private roads. A discussion ensued regarding hunters tracking wild game into the Community and that authorities (Fish & Game) should be called if this should be encountered.

It was suggested that signs be created for the Burn Pile that is adjacent to the Ranch House.
